ORDERS:-

In the reference 4th cited, orders have been issued for handing over an extent of
Ac. 1-00 Acre of Waqf Land out of an extent of Acres. 3-29 Guntas in Sy. No. 360 of
Gajwel Village for constructions of Shadi Khana, to the Special Officer Gajwel Area
Development Authority, Gajwel to facilitate the Local people of Gajwel for performing
Marriages. Accordingly the said land has been handed over by the Inspector Auditor
Waqfs Siddipet. After issuing the said proceedings Sri Syed Khader Pasha Quadri
Muthawalli of Dargah Hzt. Syed Shah Mohd Quadri (Rh) Gajwel Town Sedipet in the
reference 5th cited has requested to include certain conditions with regard to the income
of Shadi Khana and Waqf property of the said Dargah. The matter has been examined
and in partial modification of the Proceedings 4th cited, the following terms and
conditions are laid down which may be read as part and parcel of the reference 4th
cited.

TERMS & CONDITIONS

1. that, after the construction of Shadi Khana, the Shadi Khana shall be named in
the name and style as "Hazrath Syed Shah Mohammed Quadri Function Hall" &
the maintenance of Shadi Khana shall be under the Joint-maintenance of
Telangana State Waqf Board & Tahsildar Gajwel.
2. that, the superstructure of Shadi Khana together with landed property shall
always remain as Waqf Property of Dargah Hazrath Syed Shah Mohammed
Quadri R.A., Gajwel Town.

3. that, the income derived from the Shadi Khana shall be shared between the Mutawalli Telangana State Waqf Board & Tahsildar Gajwel at the proportionate ratio of 40%, 25% & 35% respectively.
4. that, the expenditure whichever will be incurred for the maintenance of Shadi Khana shall not be deducted from the 40% share of the Mutawalli and 25% of the Waqf Board.
5. that, the supervision over the functions & the maintenance shall be done by the Special Officer GADA or any authorized officer.
6. that, the Mutawalli shall be at liberty to develop remaining extent of Ac. 2-29 Guntas of Sy. No. 360 out of total extent of Ac. 3-29 Guntas for commercial / Non-Commercial purpose either by himself for leasing out the same to third parties or develop the same through third parties by leasing out the same or part thereof, with prior permission of the Waqf Board.
7. that, the above permission will be subject to the outcome of any Court cases pending before the Courts of law.

Accordingly revised proceedings are issued.
